# Minnesota Judicial State Court Salary Analysis

#### **Minnesota Judicial Salary Recommendation**

Minnesota judicial salaries have not kept pace with inflation or with other comparison salaries. In order to return salaries to the purchasing power of 2002, I recommend the following salary adjustments:

- 5.8% increase on July 1, 2013
- 5.8% increase on July 1, 2014
- 2.0% increase on July 1, 2015
- 2.0% increase on July 1, 2016

## **Judicial Salary Comparisons**

#### Minnesota judicial salaries:

- are comparable to judicial salaries in Wisconsin
- are significantly below judicial salaries in Iowa
- run about \$8,000 below the national average
- run below the national median

# **Judicial Salary Comparisons**

- The County Attorneys in the Twin Cities metropolitan area earn between 13% and 22% more than District Court Judges.
- Historically, District Court Judges have earned roughly 9% less than the Hennepin County Attorney.

# **Judicial Salary Comparisons**

District Court Judge salaries relative to new associates at large Twin Cities law firms:

- 72% more in 1983
- 49% more in 1990
- 8% more in 2012

Estimates put Minnesota District Court judges at the

- high end of the starting pay scale for new associates
- low end of the starting pay scale for attorneys with 4-9 years of experience.

## **Summary of Comparisons**

- Minnesota judges are paid below attorneys, in private practice, in other public service capacities, and in corporations.
- The gap in those salaries has been rising over time.

## Long-Run Implications of these Trends

- Talented candidates may be less willing to run or accept judicial appointments.
- Sitting judges may resign for financial considerations.
- We may end up with a judiciary in which only the wealthy, or those with fewer alternative opportunities will be willing to serve.

# **Minnesota Judicial Salary Recommendation**

My salary recommendations will

- restore judicial salaries to their 2002 levels
- move Minnesota ranking to just above the U.S. median
- restore the salary ratio of the Hennepin County Attorney to District Court Judge to its historical level
- widen the salary differential between District Court Judges and first-year associates at large Twin Cities law firms to 15%.

#### **Minnesota Judicial Salary Recommendation**

If the judges receive a 4.0% increase on July 1, 2013 and again on July 1, 2014, a

- 4.0% increase on July 1, 2015
- 4.0% increase on July 1, 2016

would restore the judges to 20o2 purchasing power.
