Greg Hubinger, Director of the Legislative Coordinating Commission (LCC), called the meeting to order at 2:42 pm. A quorum was present. Members introduced themselves. Mr. Hubinger reviewed the resolution adopted by the LCC that established the Airport Funding Advisory Task Force.

Other Business

Members discussed the appointments of additional non-voting members to the Task Force. Rep. Dill proposed adding Northwest Airlines to the list of advisory organizations represented on the Task Force. A discussion ensued.

Sen. Rest suggested the Task Force establish a formal process to appoint non-voting members to the Task Force. Sen. Rest moved the co-chairs send written correspondence to all organizations listed in the resolution, including Northwest Airlines, asking whether they want to participate in this process and, if so, to send written correspondence recommending the individual that could represent their organization on the Task Force. **THE MOTION PREVAILED.**

Rep. Dill requested members and those in the audience consider the scope of work and the deliberations of the Task Force and e-mail any suggestions to the co-chairs. Rep. Dill then gave an overview of the duties before the Task Force. He cited the Task Force would look at general aviation funding across the state; aircraft registration and fuel taxes; current and projected Capital Investment Proposals; and long-term aviation needs. Member discussion followed.
