



# Minnesota Background Studies 2018-2019 Data Overview Part 3

The information above each section of tables is intended to provide context and understanding on what data is included in each respective section. There are [Additional Notes and Data Definitions](#) at the end of this packet with more information on specific terms and data points. The tables start at a high level and then progress into more detail in each section as data is disaggregated further.

## Section 1: Count of disqualified determinations and disqualifying crimes and conduct by race/ethnicity and year

The Data Overview Part 1 included counts of all determinations completed in 2018 and 2019 broken out by disqualifying and eligible determinations. The Data Overview Part 2 took the subsection of determinations from the Data Overview Part 1 that received a risk of harm assessment, which included all disqualifying determinations and all determinations that had their disqualifications rescinded and are now eligible. This third data overview represents all determinations associated with a disqualifying crime or conduct, which is a subset of determinations represented in the Data Overview 2. This overview excludes determinations with their disqualifications rescinded that are now eligible, because these determinations no longer have disqualifying crimes or conduct associated with them. [Table 1](#) below shows total counts of all disqualifying determinations that were completed in 2018 and 2019 by race and gender. These determinations represent the totality of determinations that had one or more disqualifying crime or conduct.

Disqualifying characteristics (also referred to as “crimes or conduct”) are listed in [Minn. Stat. sec. 245C.15](#). They include convictions, admissions, preponderance of the evidence determinations that the individual has committed any of the crimes listed in [Minn. Stat. sec. 245C.15](#), substantiated determinations of maltreatment of a minor or a vulnerable adult that are found to be serious and/or recurring, failure to make a required report of a substantiated determination of serious or recurring maltreatment of a minor or a vulnerable adult, involuntary termination of parental rights, and administrative disqualifications. Disqualifying crimes and conduct may be found in BCA records, FBI records, court records, investigative records, or administrative orders or settlements. This information may be received during the initial background study process or in a Rapback (Record of Arrest and Prosecutions Back) notification, which is a notification DHS receives about new potentially disqualifying information for a background study subject with an active provider roster affiliation. Any determination that finds one or more of the disqualifying crimes or conduct above that is within the applicable lookback period must be found disqualifying. See Minn. Stat. sec. 245C.15 for the lookback periods (how long each disqualification lasts). Therefore, all of the determinations in [Table 1](#) are associated with one or more disqualifying crimes or conduct. [Table 2](#) provides counts of the total crimes and conduct that were used in the disqualification of the determinations in [Table 1](#). Since each disqualifying determination must have at least one disqualifying crime or conduct, the totals in [Table 2](#) are higher than the totals in [Table 1](#). Due to data quality issues that need more investigation to fully resolve, 39 of the 20,341 disqualifying determinations represented in the data below cannot be disaggregated at the offense level. These 39 determinations are not represented in any of the tables after [Table 1](#).

All counts for a given date range (year in this case) were defined by determinations completed in that year. This date convention is used in all sections.



## Section 2: Number of Disqualifying Crimes and Conduct per Determination

While a disqualification may be based on a single disqualifying crime or conduct, many determinations are associated with multiple disqualifying crimes or conduct. [Chart 1](#) below provides a distribution of the number of disqualifying crimes and conduct for each disqualifying determination completed in 2018 and 2019. The chart shows, for example, that 14,222 determinations had one disqualifying crime or conduct and 116 determinations had 10 or more disqualifying crimes or conduct. The number of crimes and conduct on each determination plays a role in both the complexity of the determination and the risk of harm assessed for the determination.

### Section 3: Crimes and Conduct by Disposition Type

There are multiple standards by which a disqualifying crime or conduct may be determined. For the rest of this overview, these standards will be referred to as the disposition of the disqualifying crime or conduct. Disqualifications are listed in Minn. Stat. sec. 245C.15. They are based on conviction, admission, Alford plea, preponderance of the evidence for the listed offenses, as well as committing or failing to report serious and/or recurring maltreatment, involuntary termination of parental rights, and administrative disqualifications for wrongfully obtaining assistance. [Table 3](#) breaks out the disqualifying crimes and conduct in [Table 2](#) by the disposition types above. [Table 4](#) and [Table 5](#) show the data for males and females only respectively.

Different types of crime and conduct are disqualifying for different periods of time. Disqualifying crimes and conduct can result in a permanent bar, 10 year bar, 7 year bar, 15-year disqualification, 10-year disqualification, or 7-year disqualification. Due to the various factors that can lead to different disqualification periods, a single type of offense could result in different disqualification periods. In the tables below, crime or conduct types are grouped by the years disqualifying for each crime and conduct and certain crime or conduct types may appear in multiple years disqualifying categories. The disqualification period is not captured in the data for 2,441 offenses. Offenses that do not have this information are grouped in the “Years Disqualifying Not Entered for Offense” category for years disqualified in the tables below.

## Section 4: Crimes and Conduct by Disposition Type, Crime or Conduct Type, and Years Disqualifying

This section represents the same data shown in the table in [Section 3](#), but is further disaggregated by crime or conduct type. Since there are many possible crimes in the Minnesota Criminal Code, crimes have been grouped together by their type, which is defined by the section of Minnesota Statute under which they fall. For example Minn. Stat. sec. 609.52 defines theft and there are many subdivisions within this section for various types of theft, but they have all been grouped under 609.52 – “Theft” for reporting purposes. Note that some similar types of offenses are listed separately in the Minnesota Criminal Code, and section 245C mirrors the Criminal Code, so the data will also list these similar offenses separately. For example, general theft under section 609.52 is disqualifying, but there are other sections for types of theft like [Minn. Stat. sec. 609.527](#), which defines identity theft.

Individuals may also have a disqualifying determination if it is found they have committed a disqualifying crime or conduct in another state where the elements of the offense are substantially similar to the offenses listed in [Minn. Stat. sec. 245C.15](#). In these cases, equivalent Minnesota crimes and conduct are determined and these crimes and conduct are grouped by their equivalent Minnesota Statute Section. So, for example, if theft is determined in Wisconsin under a Wisconsin law, and if it is found to be substantially similar to theft under section 609.52 in Minnesota, it will show up under 609.52 – “Theft” in the [Table 6](#) below, which is the Minnesota equivalent.

[Table 6](#) breaks out the data in [Table 3](#) by crime and conduct types grouped within years disqualifying for each type. As there are many crime and conduct types and many disposition types, the race/ethnicity category has been taken out and replaced by disposition types as columns across the top in [Table 6](#). The number of crimes and conduct types also requires that [Table 6](#) be broken up across multiple pages for readability. [Table 7](#) and [Table 8](#) show the same data represented in [Table 6](#) for males and females only respectively.

## Additional Notes and Data Definitions

1. Background Study disqualifying **data sources** can include, but are not limited to, state criminal history, federal criminal history, Minnesota Court Information System (MNCIS), other state and federal courts, maltreatment findings from Minnesota or other states, and other investigative and determination records .
2. An **eligible determination** means the background study subject was **not** determined to have committed a disqualifying crime or conduct in [Minn. Stat. sec. 245C.15](#)
3. A **disqualified determination** means the background study subject was determined responsible for a disqualifying crime or conduct in [Minn. Stat. sec. 245C.15](#)
4. A **disqualification rescinded – determination now eligible** determination means the initial determination was disqualifying and became eligible after reconsideration or appeal.
5. A **background study provider application** is the record created by the provider when submitting a background study request. Background study provider applications can be created by providers at any time. If there is already another background study determination in process for the same person, the new background study application will connect to the in process background study determination (provided the background study requirements are met). In addition, existing background study determinations can transfer to new background study provider application submissions. The connection of background study provider applications to existing background study determinations creates efficiencies for study subjects and providers.
6. For an **undetermined determination**, DHS reviews information that was received but does not make an eligibility or disqualification decision on the determination (hence the determination is “undetermined”).
7. **Active roster** means the list of individuals specific to an entity who have been determined eligible to provide services for the entity and who the entity has identified as affiliated. *See* [Minn. Stat. sec. 245C.02 subd. 17a \(b\)](#)
8. A **rapback notification** (Record of Arrest and Prosecutions Back) is a notification DHS receives about new potentially disqualifying information for a background study subject with an active provider roster affiliation.
9. An **eligible rapback determination** means that the information received through the Rapback process was found to belong to the study subject, but after review was determined to not be a disqualifying crime or conduct.
10. Disqualifying crime or conduct **disposition** describes the basis on which a crime or conduct was determined. These dispositions include conviction, admission, Alford plea, preponderance of the evidence, maltreatment, involuntary termination of parental rights, and administrative determination.
11. The Race/Ethnicity categories captured in the Background Studies system and used in the summarized data above are collected for purposes of a fingerprint-based background study. This information is reported to DHS by the provider or entity submitting the study. DHS does not collect other race/ethnicity data that would allow for different or more detailed break outs of racial or ethnic groups.
12. **Risk of Harm** is the immediate risk of harm the study subject poses to the persons receiving direct contact services based on the disqualifying information. The risk of harm factors are listed in Minn. Stat. 245C.16, subdivision 1. In other words, the risk of harm assessment at this stage of the background study process is determining whether a study subject may work, and if so with or without supervision, while the window of time for requesting reconsideration is open and while the reconsideration decision is pending. The risk assessment at this stage is different than the risk assessment done under Minn. Stat. 245C.22 when determining whether a disqualification may be set aside to allow the disqualified person to work.
  - a. **Low:** It is determined that a study subject “does not pose a risk of harm that requires continuous, direct supervision.” In this case, the study subject is allowed to continue providing services during their reconsideration request period. ([Minn. Stat. sec. 245C.17 subd. 3](#))
  - b. **Medium:** It is determined that a study subject “poses a risk of harm that requires continuous, direct supervision.” In this case, the study subject is allowed to continue providing services under continuous and direct supervision during their reconsideration request period. ([Minn. Stat. sec. 245C.17 subd. 3](#))
  - c. **High:** It is determined that a study subject “poses an imminent risk of harm.” In this case, the study subject must be immediately removed from direct contact or access to people served by the program. ([Minn. Stat. sec. 245C.17 subd. 3](#))

- d. **Not Applicable:** The risk of harm category in cases where a study subject is prohibited by statute from providing services until either an eligible determination, a set aside, or a variance has been obtained.
